GULFPORT INITIATES PUBLIC RELATIONS DRIVE

The Port of Gulfport hopes to feel out the public mood surrounding its massive expansion. A web site has been launched to inform Gulfport residents and solicit input on the final port expansion plan, designed “to reclaim the port’s capacity and competitiveness.”

“We are now listening to the community, making sure we rebuild the port in a way that preserves its longstanding local support,” said Port Director Donald Allee. Port officials said the web site is part of “a comprehensive community involvement campaign that is a critical step in producing a final port restoration plan.” The port also started a direct-mail campaign and phone research to gauge the public temperature concerning the planned expansion.

The Port of Gulfport is the third-busiest container port along the Gulf of Mexico and 17th among all U.S. ports. The Port is vital to the state’s economy and port leaders believe the plan to double its capacity could make South Mississippi a major player in international trade. With the recent boom in maritime shipping and plans to widen the Panama Canal, the Port of Gulfport says it must expand to stay competitive.

REPORT: WATER SUPPLIES THREATENED

The U.S. Forest Service has recently completed a study on the Southeast's already precarious water supplies. The study looked at four major river basins that run through Alabama, the Carolinas, Georgia, Kentucky, Mississippi and Tennessee. These river systems are among the most biologically diverse in North America. Adding to the strain on the water supply is the Southeast's population growth, which has led the nation in recent years. New development is expected to displace some 12 million acres of forest by 2020.

"Over the last century, high-quality water has been supplied at relatively low cost in the region," said Forest Service scientist Steve McNulty, who conducted the study. "That is poised to change." Parts of the Southeast had one of the worst droughts on record last year, and conditions have only slightly improved (despite the drenching of the region by Tropical Storm Fay).

The Mississippi-Alabama Bays and Bayous Symposium will be held October 28-29 at the Mississippi Coast Coliseum and Convention Center in Biloxi. If this endeavor is successful, the 2010 Annual Meeting will be back on the Coast.
